16.2 Description

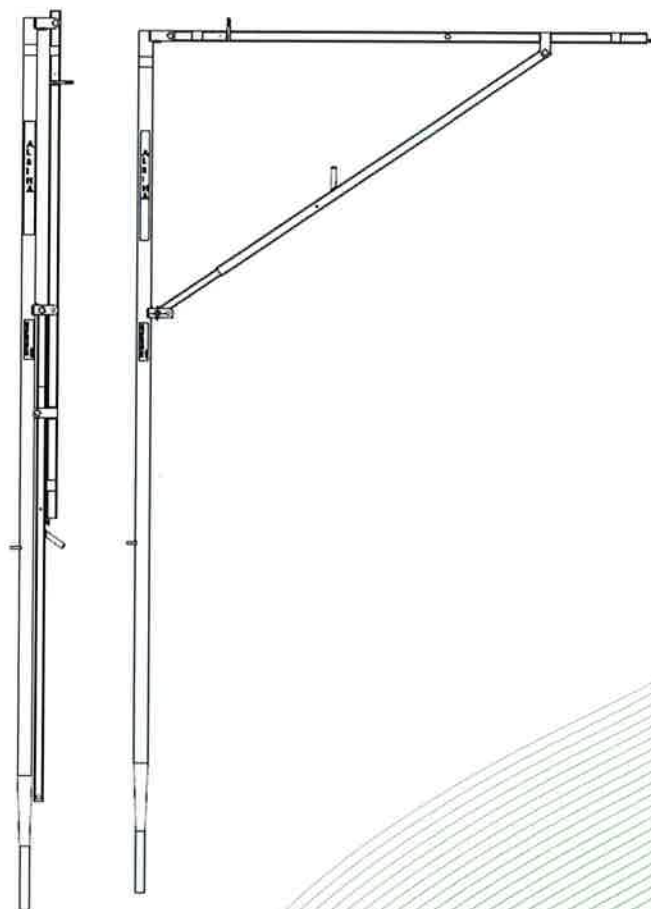


Fig. 1: Anchor device, type: Alsipercha

The anchor device of type AlsiPercha (Fig. 1) is used for the temporary protection of people against falls from a height. It is used by means of appropriate anchors (Fig. 2-6), which are installed to the structure with sufficient strength.

The corrosion-resistant anchor device is made of a pivoted Davit arm. The anchor device can be transported to the intended place of use by a crane in conjunction with appropriate transport eyelets. When erecting the Davit Arm, a cantilever is unfolded via a joint and bolted using a brace. This brace is equipped with an integrated absorption mechanism to reduce the arresting forces. At the end of the cantilever there is a welded-on eyelet which is the anchor point to which the user can connect his personal protective equipment to protect himself against falls from a height. Optionally, the Davit Arm can be used as an anchor for a type D anchor device (Fig. 7) of type Horizontal SafeAccess and NAV2 trolley made by FALLPROTEC SA. The specification of the type B anchor device is shown in Table 1.

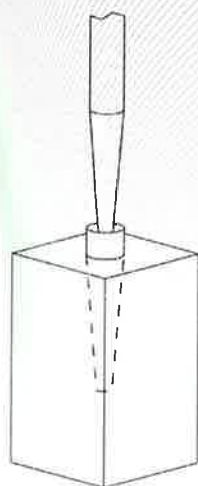


Fig. 3: Anchor, type: conical tube

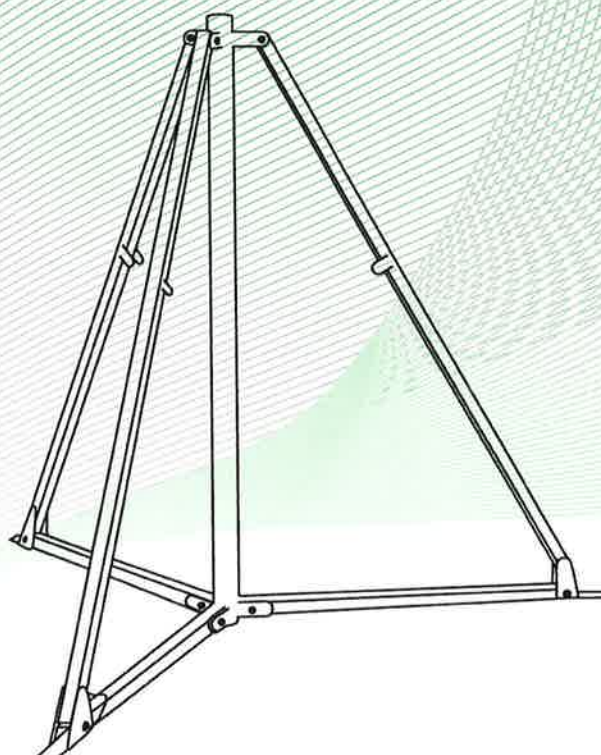


Fig. 4: Anchor, type: tripod

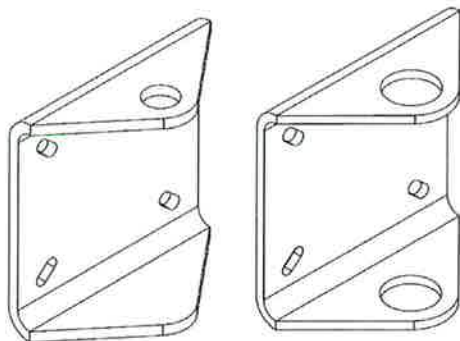


Fig. 5: Anchor, type: wall brackets

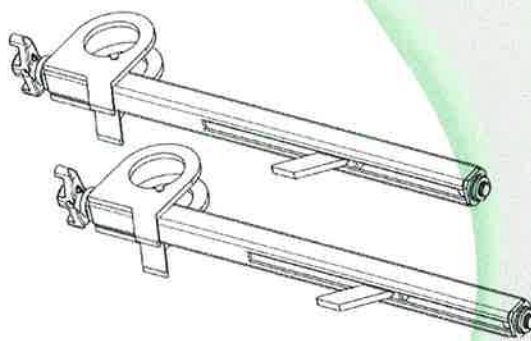


Fig. 6: Anchor, type: column clamps

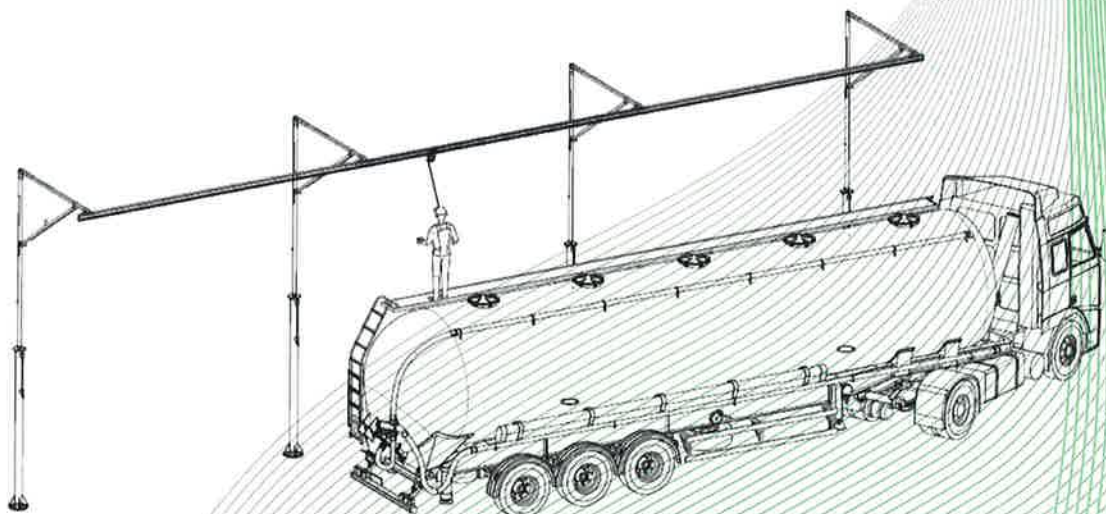


Fig. 7: Anchor device type D (type Horizontal SafeAccess and NAV2 trolley made by FALLPROTEC SA) with anchors of type AlsiPercha and post for reduced spaces

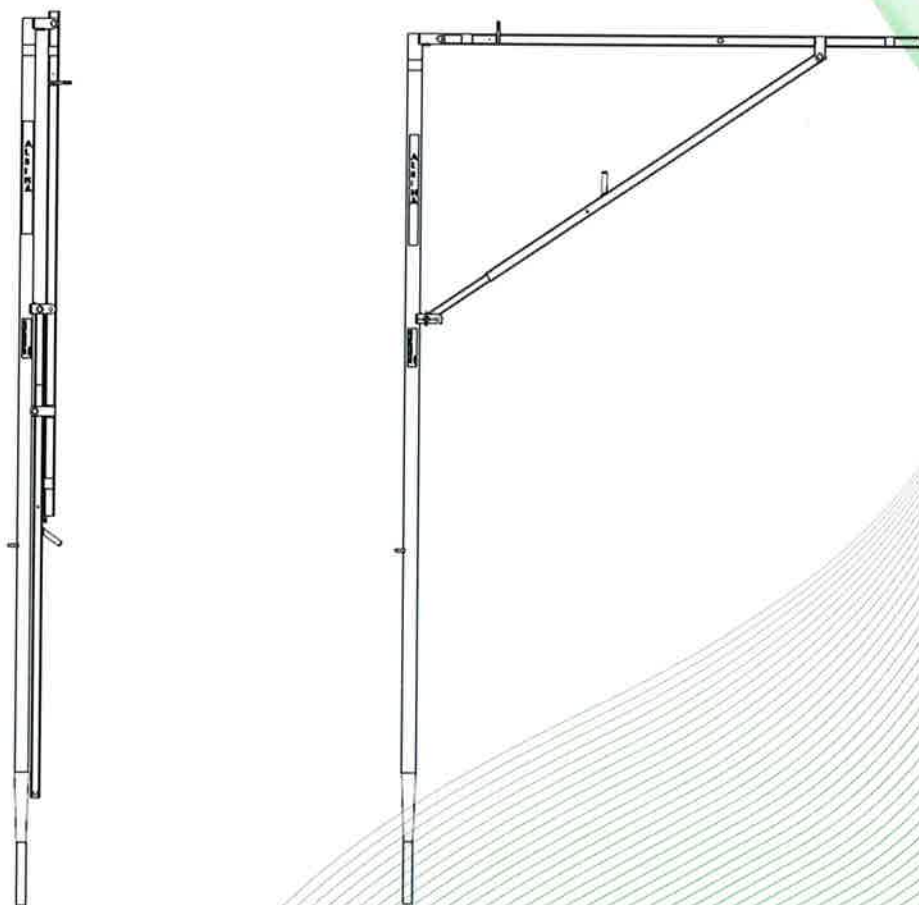


Fig. 1: Anchor device, type: Alsipercha

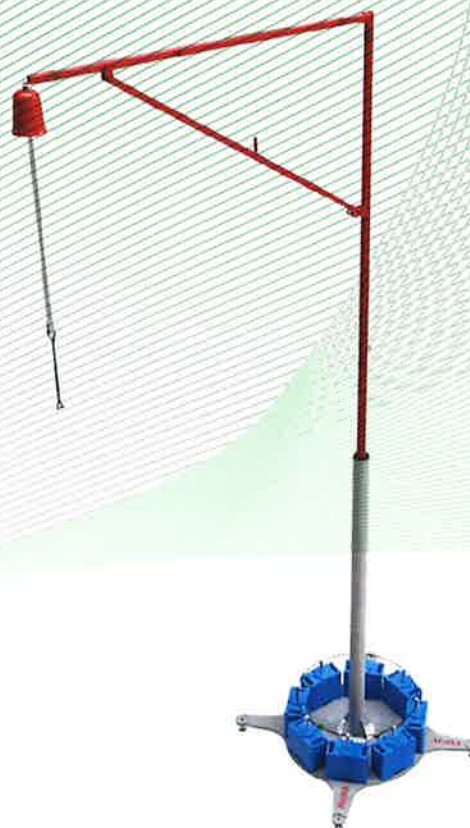


Fig. 3: Anchor, type: mobile base unit
